Environmental Protection

Use of Ultra Low Sulphur Diesel

Under the Air Pollution Control (Fuel Restriction) (Amendment) Regulation enacted in October 2008, all diesel powered equipment used on construction sites may only use liquid fuel with a sulphur content of not more than 0.005% by weight and a viscosity of not more than 6 centistokes at 40°C, e.g. ultra low sulphur diesel (ULSD). Environmental Protection Department staff will collect fuel oil samples from your equipment during their regular inspection to construction sites. Contractors are advised to maintain good record of their fuel purchasing document as proof of compliance. 使用超低含硫量柴油

根據2008年10月實施的《空氣污染管制(燃料限制)(修訂)規例》，所有在工地使用的柴油推動設備，必須使用含硫量(以重量計)不超過0.005%，以及在攝氏40度時黏度不超過6釐斯托克斯的液體燃料，如超低含硫量柴油。環保署人員將定期到工地巡查，期間從設備收集燃料樣本。承建商應妥善保存購買燃料的收據，以證明已轉用符合規格的燃料。請於以下網站(http://www.epd.gov.hk/epd/tc_chi/environmentinhk/air/guide_ref/guide_fuel_restriction.html) 瀏覽更多有關規例的資料。

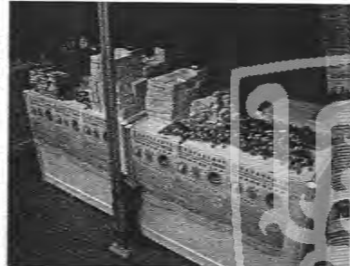
